5. (a) I agree that the War Relocation Authority may designate the means and route by which the property is to be transported. I understand and agree that the transportation of my property shall be via the most economical means. I also consent to your placing on my property the valuation (on which any claim I may have against the carrier for loss or damage will be based) which applies when property is shipped at the lowest freight rate available. (I understand that if I desire a higher valuation, I must request it in writing at this time, and must pay in advance the additional freight charge added by reason of such higher valuation, or the insurance premium.)

(b) I shall pay all expense connected with transporting the property, including the insurance

premium, if any. I choose to have the property transported via ______. To cover this expense I shall deposit with the Transportation Section, San Francisco office, in advance of shipment of the property, the amount of money requested of me for that purpose.

6. In the event any of my property is perishable, or is (or becomes) contaminated or if it may lead to the contamination of other property, I authorize the War Relocation Authority to dispose of such property (or any part thereof) without notice, by whatever method it chooses, without expense to me. If any proceeds are realized from the disposition of such property, those proceeds are to be remitted to me in full.

7. If any commercial property (that is, any property other than clothing, household furniture, kitchen equipment, utensils, and hand tools) is included in the list of my property on the reverse side hereof, such property is to be transported at my expense. To cover that expense, I am depositing with



I hereby release and discharge the War Relocation Authority and its employees and representatives of and from all liability whatsoever arising out of or resulting from packing, storing, transporting, or otherwise handling my household and personal effects and any and all other property belonging to me or in which I have an interest.
